



Countdown Promotion | Terms and Conditions

1. These terms and conditions together with any other specific rules set out in this competition entry form ("Entry Form") are the competition rules ("Rules"). By submitting this Entry Form, entrants agree to be bound by these Rules.
2. ADNZ reserves the right to cancel or amend the competition, the Entry Form or these Rules at any time for any reason without prior notice.
3. In the event of any dispute regarding the Rules, this Entry Form, conduct, results and all other matters relating to the competition, the decision of ADNZ shall be final and no correspondence or discussion shall be entered into.

Entrants

4. To qualify to enter the competition an entrant ("Entrant") must be resident in New Zealand.
5. Employees of ADNZ or any other company involved in the competition (including Progressive Enterprises Limited, and Resene) or members of their families or households, are not eligible to enter the competition. ADNZ reserves the right to verify the eligibility of all Entrants.
